Terms and Conditions

1. Payment of all Buy Local Invoices must be paid within 14 days of the date of issue or your terminal will be removed from the authorised terminals database and you will be unable to redeem any gift cards until your account has been settled. A \$30 +GST fee will be charged to have your terminal/s re-authorised.
2. Commerce North West will be allowed access to the business eftpos terminal/s to authorise it to accept the Commerce North West Gift Cards.
3. If your business will have exceptions to the Gift Cards use instore, you need to inform Commerce north West for inclusion of this information on their website. Additionally, you need to inform your customers prior to the point of sale of any exceptions your company has when it comes redeeming the gift cards for any particular products or services.
4. If exclusions change you will need notify us in writing via email [manager@commercenorthwest.com.au](mailto:manager@commercenorthwest.com.au)
5. I understand that my company name and logo will be listed on the participating businesses register and other promotional materials as these arise.
